This is to inform you that our company changes the business name from KTBST HOLDING PUBLIC COMPANY LIMITED (KTBST Group) to DAOL (THAILAND) PUBLIC COMPANY LIMITED (DAOL (THAILAND)), effective August 15, 2022.

The name change is consequence of KTB Investment & Securities based in South Korea, which is a major shareholder of KTBST HOLDING PUBLIC COMPANY LIMITED (KTBST Group), changed its name and logo to DAOL Investment & Securities on March 25, 2022 to reflect the identity of the major shareholder with Korean nationality. DAOL (다음) means "everything that attracts good fortune".

As a result, KTBST HOLDING PUBLIC COMPANY LIMITED (KTBST Group) changes its name to DAOL (THAILAND) PUBLIC COMPANY LIMITED (DAOL (THAILAND)) and its subsidiaries change name and logo as well. The details of the changes are as follows:


